Planned Parenthood: All About Abortion

Despite the name, Planned Parenthood has very little to do with "parenthood" and everything to do with the destruction of unborn children. The Planned Parenthood Federation of America (PP) is the largest abortion provider in the United States, killing unborn babies at an ever-increasing rate, 332,000 abortions in 2009, 1000 a day, over 5.5 million since 1977. PP is also being funded at an ever-increasing rate by the government, \$365 million in 2009 or about one-third of PP's yearly revenue.

The PP empire includes 85 affiliates, 820 separate locations, \$1 billion in assets, and a \$1 billion annual budget. Its biggest facility is a new, \$26 million, six-story, 78,000-square-foot, 7,000-abortions-per-year "mega-clinic" in Houston, Texas, one of a growing number of PP mega-clinics in the United States. A

few PP affiliates do not provide abortions, but this is soon to change: The Federation has decreed that all affiliates must begin selling abortions no later than 2013.

According to PP, 70% of its services consist of birth control distribution and STD screening and treatment, while abortion amounts to a mere 3% of what they do. This is entirely misleading. PP arrives at these figures by unbundling its services. For instance, let's say that a PP "clinic" does 50 abortions on a particular day. If each client is handed a packet of birth control while leaving the facility, abortion now accounts for only 50% of the services provided, and the incidental contraceptive handout appears, on paper, to be major part of the day's activities.

For a more realistic picture, it is important to know that in any given year a

full 12% of PP's clients get an abortion. In 2009, this amounted to 332,278 abortions, nearly 28% all the abortions done in the United States. Abortion is PP's biggest source of clinic revenue. By very conservative estimates at least 37% of all revenue generated by PP clinics comes directly from doing abortions. Less than 3% of PP's pregnant clients actually become parents; 0.3% are referred to an adoption agency and only 2% are given some form of prenatal care. PP is all about abortion.

Many Americans, disgusted by these facts and figures, are demanding that President Obama stop borrowing money from places like communist China so he can give it to an agency that is killing American babies by the hundreds of thousands. A national campaign continued on page 6

Pro-life bills introduced in the state General Assembly

After eight years of pro-abortion Gov. Ed Rendell and almost seven years of proabortion Gov. Tom Ridge, Pennsylvania has elected a pro-life governor.

With Gov. Tom Corbett now in-charge, there is no longer the high likelihood of a veto whenever a bill that is not to the liking of the abortion industry lobbyists reaches the governor's desk. Now is our chance to make up for lost time, and the Pennsylvania General Assembly appears poised to do just that. A number of pro-life bills have been introduced, so it is important that we tell our legislators that we want action.

There is an urgent need to resolve some serious deficiencies in Pennsylvania's oversight of abortion providers and to exercise the state's right to opt out of the abortion-funding provisions of the Obama health care law.

Although it is not possible at the present time to fully protect unborn babies from the brutality of the abortion industry, more can be done to protect abortion clients. Abortionists should be held to the same medical safety standards that apply to legitimate health care providers. This is currently not the case.

With the recent discovery of inhuman conditions at an abortion facility in Philadelphia, which even *The Nation*, a very liberal publication, referred to as "Dr. Kermit Gosnell's Horror Show," it has become all too clear that Pennsylvania has failed to properly regulate abortion facilities. After 20 years of mayhem, Gosnell is finally under arrest, for the recent murders of a patient and seven babies who were born alive in his facility. Several bills have been introduced to ensure that other "reproductive rights" horror shows are not allowed to flourish in our state while regulators look the other way.

State Rep. Matt Baker is sponsoring three bills: H.B.574 would requre abortion facilities to comply with the same safety standards that cover other ambulatory surgical facilities; H.B.908 would increase the penalties for impersonating a physician; and H.B.907 would change the statute of limitations for infanticide and late-term abortion. All of these offenses are alleged to have taken place in Dr. Gosnell's facility.

State Sen. Jake Corman has introduced

S.B.642, which would establish a licensing process for abortion facilities and make annual inspections mandatory.

State Rep. Kathy Rapp, whose district includes neighboring Warren County, has introduced the *Women's Right to Know Law*. The bill, H.B. 1077, would protect a woman's right to make an informed choice by requiring abortion providers to do an ultrasound exam and ask the woman seeking an abortion if she would like to see an image of her unborn child before an abortion takes place.

In order to maintain Pennsylvania's policy of not using government money to pay for abortion, State Sen. Don White has introduced S.B.3, which would remove abortion coverage from insurance plans operating in Pennsylvania that are subsidized by the Obama health care law. An identical bill, H.B.912, has been introduced in the House by State Rep. Nicholas Micozzle.

Survey Questions

- **1. LEGAL PROTECTION FOR THE UNBORN** ... If changes to *Roe v. Wade* make it possible, would you favor the enactment of a law prohibiting abortion, or prohibiting abortion with exceptions? (Please specify what exceptions, if any.)
- **2. LATE TERM ABORTIONS** ... Should abortions be prohibited in all cases where the unborn child is mature enough to survive apart from his or her mother?
- **3. INFORMED CONSENT** ... Should abortion providers be required to offer basic information to a woman who is considering an abortion, such as information about the medical risks, alternatives to abortion, the probable gestational age of her unborn child, the availability of detailed information (provided by the Commonwealth of Pennsylvania) about fetal development and the possibility of medical assistance benefits if the woman decides to continue her pregnancy? (Currently required under Pennsylvania law.)
- **4. TIME FOR DELIBERATION** ... After initially consulting with a physician, should a woman who wants an abortion be given 24 hours to carefully consider her decision before an abortion is carried out?

(Currently required under Pennsylvania law.)

5. PARENTAL INVOLVEMENT ... If a woman seeking an abortion is less than 18 years old, should the consent of at least one parent be required unless a judge determines that extenuating circumstances are involved? (Currently required under Pennsylvania law.)

6. GOVERNMENT FUNDING ... Should public funds be used to pay for abortions?

7. ASSISTED SUICIDE ... Should physician-assisted suicide be allowed?

8. EMBRYO DESTRUCTIVE RESEARCH ... Should government funds be used to pay for research that involves the destruction of human embryos (embryonic stem cell research)?

and restore conscience protection; H.R. 3 to stop *all* abortion funding; and H.R. 217 to deny Title X funds to agencies that do abortions. He voted for H.R. 2 to repeal the Obama health care law and voted twice to de-fund Planned Parenthood.

Response to Comments from the Candidates

People for Life thanks all those who participated in our Candidate Survey. Some candidates took the time to include additional comments and even, in a few cases, to challenge the propriety of the Survey itself. We appreciate any and all feedback.

We are not surprised when a candidate disagrees with us on the issues. But what is surprising is that some candidates seem to think that the public has no right to know where they stand on these issues, issues that are not only important but paramount for many people.

True, local public officials do not usually determine the laws and policies that are considered in the Survey, but the questions are still relevant. Polling companies ask even private citizens the same kinds of questions in order to accurately gage where they stand on abortion and related human life issues.

We will respond here in a general way to some of the additional comments that were submitted by the candidates.

Judicial Offices

Three of the candidates for District Judge stated that the *Pennsylvania Code of Judicial Conduct* prevented them from disclosing their views to the voters. According to the *Code*, "Judges should refrain from political activity inappropriate to their judicial office." But should all "political activity" be considered "inappropriate"? Running for office is itself a political activity. Conversely, should affirming one's support for the most basic of human rights be considered political activity in the first place?

Several state codes of judicial conduct have been challenged in court in recent years, most notably by constitutional attorney James Bopp, who serves as general counsel to National Right to Life. A number of courts have ruled that limitations on judicial candidates' ability to express general opinions on the issues of the day are unconstitutional violations of the candidates' First Amendment free speech rights.

Not all judicial candidates think the *Code* prevents them from sharing their views about human life. For example, a candidate who went on to win election to a statewide judicial office spent nearly an hour freely and forcefully sharing her pro-life views with the volunteers at our Erie County Fair outreach booth in 2009. Also that year, in the campaign for an open seat on the Erie County Court of Common Pleas, five candidates answered our questionnaire, three simply failed to respond, and only one declined to respond by invoking the *Code*.

Declining to respond because of concerns about the *Code* should not, however, be seen as evidence of pro-abortion leanings. One candidate, for example, who invoked the *Code*, Sue Strohmeyer, was known as a pro-

life person well before she ran for public office, and we have no reason to think this has changed.

District Attorney

Incumbent District Attorney Jack Daneri took the time to respond with a formal letter even though he is running for reelection unopposed. He did, however, decline to share his views. He asserted that personal views are not relevant as long as a district attorney is faithful to his duties and the letter of the law. Unfortunately, given the constraints on time, limited resources, and, yes, political realities, law enforcement officials are obliged to constantly make decisions about when, where, and how to enforce the law. Those decisions will inevitably be influenced by an official's personal values, sense of priorities, and perception of the character and motives of parties involved in cases that arise.

For example: Some Erie-area residents were threatened with arrest by school officials and police officers for distributing benign pro-life literature on a public sidewalk to passersby near a local high school. When one of the assistant district attorneys was consulted, he responded by admitting that this might be a violation of the pro-life resident's free speech rights. His advice, however, was to get a good lawyer before attempting to distribute any more literature because, no matter what, the DA's office would prosecute the leafleteers on behalf of the school district if requested to do so.

A pro-life assistant district attorney might have been more inclined to try to resolve the situation in a way that would equitably protect the rights of everyone involved, including the pro-life citizens. (This episode occurred a number of years ago and is in no way intended to reflect on the current candidate for district attorney.)

School Boards

There can be no doubt that certain elected offices are more crucial to the prolife cause than others. The most crucial offices are those of U.S. President and U.S. Senator. The president nominates Supreme Court justices and the Senate confirms them. The current Supreme Court is the main obstruction to legal protection for the unborn.

The issue of abortion might not figure prominently in a race for city dog catcher, but it should not be difficult to see why a voter might be concerned about a school board candidate's views on the subject. Nevertheless, some school board candidates do get upset when they receive our Survey. And they occasionally respond with an indignant, "None of your business!"

One school board candidate submitted pro-life responses to seven out of eight questions but still wrote that he "took exception" to the survey because abortion has "absolutely nothing to do with the position of school director." Just the day before, ironically, we heard from a former People for Life member, Farrah Morelli, who is running for school director in Delaware. She is doing so specifically to help keep Planned Parenthood, the nation's largest abortion provider and promoter, from controlling the sexuality curricula of the middle and high schools in her community.

We depend on school boards to ensure that public schools treat the pro-life viewpoint – and those who hold it – with at least a moderate amount of fairness, balance, and respect. Cases from around the nation, unfortunately, show that this is not always the case.

Remember last year when a school maintenance man in Virginia passed out a handful of educational three-month fetal models to some students? Perhaps the man should have been advised not to pass things out at school, but his immediate suspension and the fierce howls of outrage and condemnation from school officials were telling.

Abortion can become a school issue in various ways. Students are sometimes forbidden to write or speak about abortion. Teachers sometimes feel pressured to hide their personal viewpoints, even though practically every other subject is up for discussion. Students have been ordered to remove shirts with pro-life messages or to turn them inside-out even though other messages, including unseemly ones, are routinely ignored.

But while students are being thus "protected" from the topic of abortion, at the other extreme in what are hopefully truly rare instances, school personnel have helped students obtain secret abortions. No school director, except a radically pro-abortion ideologue, would condone secret abortions. But in light of such experiences, who could honestly believe that abortion and human life issues have "absolutely nothing to do with the position of school director"?

KELLY TO DC MAYOR: OBEY LAW

Congressman Mike Kelly is one of 85 U.S. Representatives who sent a letter to DC Mayor Vincent Gray urging him not to violate the recently reinstated ban on government funding of abortion in the District of Columbia. When a ban was put in place in 1996, DC violated the law for two years.

to de-fund PP is underway, and People for Life members are getting involved.

Director Tim Broderick and two others took part in a "Vigil for Victims" on Valentine's Day outside the PP abortion facility in Pittsburgh. The three were interviewed as they were leaving for Pittsburgh, and a TV report aired in Erie later that day.

PP had just been caught on video conspiring with people posing as sex traffickers to arrange secret, illegal abortions for underage victims of prostitution.

Twenty-one rallied against government funding for PP outside the Erie offices of U.S. Senators Pat Toomey and Bob Casey on March 3. Toomey has since voted twice to stop funding. Casey, who claims to be "prolife," has voted twice to continue funding.

On March 8, 75 members and friends of People for Life joined Lila Rose of Live Action Films and her "Expose Planned Parenthood" bus tour for a rally in front of pro-life Congressman Mike Kelly's office. Kelly strongly supports the de-funding effort.
