January events show pro-life energy, resolve

January is always a very active month for the pro-life community here in northwestern Pennsylvania and all around the nation. It is when we mark the anniversary of the infamous *Roe v. Wade* Supreme Court decision that legalized abortion in all 50 of the United States.

People for Life sponsored three pro-life events during January that were designed to inspire and energize the local pro-life community and raise awareness about human life issues among the general public. All three events were very successful, thanks to outstanding support from hundreds of People for Life's dedicated volunteers, members, and friends.

Erie March for Life

Approximately 300 people participated in the Erie March for Life on January 12, almost double the number in previous years. The theme of the March was "Protect Every Child." Mercyhurst University's Lakers for Life lead the march carrying a brand-new "Erie March for Life" banner donated by Signs by Renee of Saegertown. The Catholic Youth Ministry of the Erie Catholic Diocese actively supported the Erie March this year, turning out approximately 60 marchers, most of them teenagers.

Pro-Life Breakfast

A week later on January 19, nearly 600 people attended People for Life's 35th Annual Pro-Life Breakfast to hear our special guest speaker, internationally acclaimed author and network news commentator George Weigel.

It was the first time that the Pro-Life Breakfast was held at Erie's Bayfront Convention Center. We are happy to announce that the Breakfast will be held at the Convention Center again next January.

We were *doubly* honored this year to host not one, but two Catholic bishops:

Bishop Donald Trautman and Bishop Lawrence Persico, and two pro-life Congressman: U.S. Rep. Mike Kelly and U.S. Rep Glenn "GT" Thompson.

Bishop Persico spoke with conviction in support of the sanctity of human life and local pro-life efforts. Both congressmen spoke eloquently about their pro-life convictions and their commitment to the pro-life cause.

Matt Blackburn spoke on behalf of prolife U.S. Senator Pat Toomey. Matt is Senator Toomey's Director for Western Pennsylvania and a former People for Life board member.

Other special guests included pro-life State Reps. Michelle Brooks and Curt Sonney, and Michael Ciccocioppo, the Executive Director of the Pennsylvania Pro-Life Federation. Pro-life State Rep. Ryan Bizzarro was represented by his Chief of Staff Julie Slomski and Deputy Chief of Staff Sean Eperjesi.

March for Life Bus Trip

People for Life's *Roe v. Wade* activities concluded with a record-breaking Bus Trip to the Washington, DC March for Life on January 25. Five motor coaches were needed for the first time in the Bus Trip's 40-year history, to transport all of our 255 marchers. The previous record was 220 marchers, set in 2012. The March for Life itself also broke all previous records, with an estimated attendance of over 500.000.

Survey Questions

- **1. LEGAL PROTECTION FOR THE UNBORN** ... If changes to *Roe v. Wade* make it possible, would you favor the enactment of a law prohibiting abortion or prohibiting abortion with exceptions? (Please specify what exceptions, if any.)
- **2. LATE TERM ABORTIONS** ... Should abortions be prohibited in all cases where the unborn child is mature enough to survive apart from his or her mother?
- **3. INFORMED CONSENT** ... Should abortion providers be required to offer basic information to a woman who is considering an abortion, such as information about the medical risks, alternatives to abortion, the probable gestational age of her unborn child, the availability of detailed information (provided by the Commonwealth of Pennsylvania) about fetal development and the possibility of medical assistance benefits if the woman decides to continue her pregnancy? (Currently required under Pennsylvania law.)
- **4. TIME FOR DELIBERATION** ... After initially consulting with a physician, should a woman who wants an abortion be given 24 hours to carefully consider her decision before an abortion is carried out? (Currently required under Pennsylvania law.)

5. PARENTAL INVOLVEMENT ... If a woman seeking an abortion is less than 18 years old, should the consent of at least one parent be required unless a judge determines that extenuating circumstances are involved? (Currently required under Pennsylvania law.)

6. GOVERNMENT FUNDING ... Should public funds be used to pay for abortions?

7. ASSISTED SUICIDE ... Should physician-assisted suicide be allowed?

8. EMBRYO DESTRUCTIVE RESEARCH ... Should government funds be used to pay for research that involves the destruction of human embryos (embryonic stem cell research)?

Ed Brezinski ◆1. "Rape" ◆4. "At least" Donald "Whitey" Cleaver ◆7. Answered both "yes" and "no." "As I get older I am in the middle of the road."

John F. Evans ◆ Returned a letter that is too long to print in its entirety but can be summarized by the following excerpts: "[I]t seems unlikely to me that any significant right to life issue will come before City Council.... Therefore, I do not see any rationale for having a position.... I am concerned that your group would focus on this issue in a local municipal election. By far, the most pressing problem our community faces is vanishing financial support from the federal and state governments.... However, speaking as a private citizen, I have been a solid right to life supporter..."

The trial of abortionist Kermit Gosnell

The prosecution rested its case on April 18 in the trial of Philadelphia abortionist Kermit Gosnell, after six weeks of gruesome testimony.

Gosnell, 72, was being tried on 26 charges, including the first-degree murder of seven infants born-alive during late-term abortions and the third-degree murder of 41-year-old Kareema Cross by an overdose of Demerol and other pain medication administered by untrained employees. (As we go to press, we have learned that the judge has dropped three of the first-degree murder charges.)

The final witness for the prosecution was former Gosnell employee Kareema Cross, who testified that she had personally seen more than 10 babies who had continued breathing after their deliveries and three babies who were also moving.

The jury was shown pictures of lateterm aborted babies that Cross had taken at Gosnell's "clinic." One was estimated by trial experts to have been aborted in the 30th week of pregnancy.

Gosnell ran the Women's Medical Society abortion facility in West Philadelphia from 1979 until 2010. It was finally shut down after being raided by the FBI as part of an investigation into Gosnell's distribution of Oxycontin and other federally-controlled substances. Illegal trafficking in controlled substances is endemic to the abortion industry.

The FBI discovered a lot more than evidence of illegal drug activity: Bloody floors, blood-stained blankets, a flea-infested cat roaming freely amid the smell of urine, and semi-conscious women

moaning in the waiting and recovery rooms.

A subsequent Health Department inspection found that surgical instruments were not properly sterilized, disposable medical materials were being reused, ultrasound information was being falsified, emergency equipment was inoperative, and fetal remains were haphazardly stored throughout the facility.

A grand jury investigation produced a 300-page report that strongly criticized multiple government agencies for ignoring numerous complaints and 46 lawsuits against Gosnell. It also criticized the administration of pro-abortion Governor Tom Ridge for discontinuing inspections of Pennsylvania abortion facilities.

Pennsylvania Superior Court

In the race for Judge of the Pennsylvania Superior Court, the PA Pro-Life Federation PAC is recommending republican candidate Vic Stable. The positions of the two democratic candidates are unknown.

Does it matter what local candidates think about abortion?

People for Life thanks all those who responded to our Candidate Survey. Some candidates took the time to include additional comments and, in a few cases, to criticize the very idea of our asking for their views on human life issues.

We are usually not surprised when a candidate disagrees with us on some or all of the issues. But what is surprising is that some candidates think that the public has no right to know where they stand on such important issues, issues that rank as the highest priorities for many people.

It is certainly true that local public officials are, in most cases, not directly responsible for enacting the kinds of laws and policies that are considered in our questionnaire, but the questions are still relevant. Polling companies ask even private citizens the same kinds of questions in order to accurately gage where they stand on abortion and related issues.

There are many pro-abortion elected officials, and others with conflicted or foggy ideas about the issues involved, who perform their public duties very capably. In most instances, their thinking about the deeper questions facing our society does not have a direct bearing on their job performance. But the following examples should help to illustrate that a local official's position on

human life issues can, at least occasionally, be very crucial:

In 2007 the county commission of Sarasota, Florida voted unanimously to authorize an \$8 million bond to allow Planned Parenthood to build a 22,000 square foot abortion facility in that community.

In 2011 the New York city council voted 39-9 for a measure, supported by Mayor Bloomberg, to force crisis pregnancy centers to refer clients for abortion or else post large signs that would be likely to send the message that abortion is simply a routine "solution" for unplanned pregnancy.

Earlier in 2011, a federal judge struck down a similar law that had been enacted by the Baltimore city council on a vote of 12-3. (The New York law was subsequently crafted to address the court's objections to the Baltimore law.)

Harford County, Maryland was forced to pay a settlement, in 2011, for the mistreatment of pro-life demonstrators after they were illegally arrested and incarcerated in the Harford County jail.

In 2010 the mayor and city counsel of Huber Heights, Ohio debated a tax levy which would have helped fund a local Planned Parenthood facility. Planned Parenthood is the largest provider – and promoter – of abortion in the United States.

Also in 2010, the City of Rockford Illinois, due to the influence of three proabortion alderman, refused to issue a routine permit for a mobile ultrasound unit to park near a local abortion facility saying ridiculously that the people operating the unit "may begin to jump out from behind parked cars into oncoming traffic to stop cars and force pro-life information on them."

In 2009 it was reported that the town of Belleview, Nebraska was paying \$1000 a month to provide security cameras for abortionist LeRoy Carhart's third-trimester abortion facility.

The bottom line is this: Our national devaluation of human life raises serious issues throughout our entire society, including local government and the educational system. The good news is that there are many very talented and capable elected officials and candidates for public office who fully understand the value of human life. These are men and women for whom the dignity of every human being and respect for basic human rights are the guiding compass for all they do. These are the kind of people we need in public office – in all elected offices and levels of government.

H.B. 818: State Rep. Flo Fabrizio casts pro-abortion votes, lobs old feminist slur

The Health Committee of the Pennsylvania House of Representatives voted 15-9, on April 15, to approve H.B. 818, a bill to prevent government-subsidized insurance plans created under the Affordable Care Act (Obamacare) from paying for elective abortions within the Commonwealth.

It was a party line vote, except for a single democrat who broke ranks to support the legislation.

The ranking democrat on the Health Committee, pro-abortion State Rep. Florindo "Flo" Fabrizio of Erie, voted against the bill (i.e., voted *for* government-funded abortion). He also dropped a rhetorical bombshell, likening abortion to a "sacrament."

"A nun told me this one time," said Fabrizio, "but I'm going to pass it on because it really registered with me. She said, 'If men could get pregnant, abortion would be a sacrament." One might guess that the four women on the Health Committee who voted for the bill were as disgusted as anyone by these remarks.

Rep. Fabrizio also voted for an amendment which would have greatly weakened the legislation or rendered it meaningless. The amendment, which was defeated on a straight party-line vote of 1410, would have allowed insurance coverage if the abortion was necessary for "health" reasons in the "good faith" judgment of the abortionist.

State Rep. Matt Baker, the ranking Health Committee republican, drew applause from some of his fellow legislators when he said he did "not believe health care should include killing babies."

H.B. 818 clears State House

On April 23 the Pennsylvania House of Representatives approved H.B. 818 with a bipartisan vote of 144 (107 republicans and 37 democrats) to 53.

Please thank the following northwestern Pennsylvania state representatives for voting to maintain the longstanding policy of no government-subsidized abortion in Pennsylvania: Ryan Bizzarro, Michele Brooks, Pat Harkins, Greg Lucas, Kathy Rapp, Brad Roae, and Curt Sonney. State Rep. Flo Fabrizio voted against the legislation when it was brought to the floor, as well as when it was in his committee.

A pro-abortion amendment that would have severely weakened the bill or rendered it meaningless was defeated on the floor of the House prior to the bill's final passage by a nearly straight party-line vote of 87 to 102. It contained vague language that authorized government-subsidized insurance plans to pay for elective abortion as long an unspecified token amount of private money was contributed by the insurance policy holder. Erie area State Rep. Ryan Bizzarro was one of only eight democrats who crossed party lines to vote against this proabortion amendment.

H.B. 818 will now be taken up by the Pennsylvania State Senate. Please call and e-mail your state senator and say that you want him or her to support H.B. 818 and continued of page 5
